

Ordinance & Police Committee Meeting – January 14, 2019

The Ordinance & Police Committee of the City of Aledo met in Open Session in the Council Chambers of the City Hall building on January 14, 2019. Chairman MICHAEL CHAUSSE called the meeting to order at 6:00 P.M. The roll was called, whereupon the following committee members answered present:

Aldermen ILA BERTRAND, MICHAEL CHAUSSE, and CHRIS KOPP. Mayor CHRISTOPHER HAGLOCH. Alderman TERRY BEWLEY was absent.

Also present were BARRY COOPER, Alderman, JIM HOLMES, Alderman, CHRIS SULLIVAN, Interim Administrator / Chief of Police, JUSTIN BLASER, Director of Public Works & Utilities, and JAROD DALE, City Clerk.

Approval of Committee Minutes: Motion was made by ALD. KOPP and seconded by ALD. BERTRAND to approve the Ordinance & Police Committee meeting minutes of 05/29/18 as presented. A Unanimous voice vote followed in agreement.

*Discussion & Request by Randy Franks, d/b/a Dancer's Creek Barn, 702 NW 9<sup>th</sup> Avenue, Aledo, Il., 61231, to Amend Section 3-2-8 of the City Code allowing an Additional Liquor License within the Corporate Limits of the City of Aledo:* MAYOR Hagloch reported currently, there are four (4) Classes. The classes are designated as follows:

- Class "A" – Club
- Class "B" – Package
- Class "C" – Tavern
- Class "D" – Restaurant

MAYOR noted to possibly be considered under a Class "A" liquor license.

ALD. Cooper arrived at 6:03 p.m.

Mr. Franks was in-attendance and reported the liquor license application was submitted for a special event venue. Purpose of the event location is to hold receptions or events at 702 NW 9<sup>th</sup> Avenue, Aledo, Il. There being no additional debate the Chair announced the following:

Motion was made by ALD. CHAUSSE and seconded by ALD. KOPP to grant Mr. Franks a liquor license at the property listed above and to instruct the city attorney to draft an ordinance finalizing the class and forward to the Aledo City Council for final approval.
